



LNCOA Blended Learning Environment



On 1 October 2022, the Logistics Noncommissioned Officer Academy transitioned to a phased blended learning environment (BLE). Please read below and assist us in disseminating this information to the force.

The Logistics Noncommissioned Officer Academy (LNCOA) Advanced Leader Course (ALC) and Senior Leader Course (SLC) Blended Learning Environment (BLE) Information Sheet:

To assist leadership and NCOs slotted to attend ALC or SLC at Fort Gregg-Adams's LNCOA, this message addresses TRADOC directed changes to current training delivery methods. **Beginning 1st Quarter, FY23, LNCOA ALC and SLC Professional Military Education (PME) courses transitioned to a phased BLE.**

This information applies to COMPO 1, 2, and 3 NCOs scheduled for PME at the LNCOA. **COMPO 2 and 3 NCOs** will receive additional guidance from their home station leadership as it relates to TDY and funding for all phases.

Beginning August 2022, Students will receive notifications from the Army's Training Requirements and Resources System (ATRRS). It is extremely important that students conduct a thorough review of all correspondence received and contact LNCOA Operations @ 804-765-8915/8916/8917 with any questions.

Students will receive a separate ATRRS notification for Phase 1 and 2 enrollments. Students will complete Phases sequentially, as scheduled by HRC. The notification encompasses basic information such as start date and course length.

It is the chain of command's responsibility to ensure that the student is qualified to attend this course. **Leadership must ensure that time is available during the duty day for Soldiers to complete DA-directed synchronous training and structured self-development.**

Phase 1: Students will remain at home station and receive synchronous Virtual Learning (VL) through Blackboard.com IAW their ATRRS reservation.

- Students will receive a detailed Welcome Letter approximately 30 days prior to their course date.
- Instruction conducted on Blackboard.com requires personal devices, wi-fi, and a web camera. Recommend this is unit supplied.
- Synchronous Instructor led training begins at **0830 (Eastern Standard Time)** daily in line with welcome letters.
- Synchronous instruction entails daily discussions with instructors for three hours each day for the first three days. Instruction on day four of VL courses that are over three days, increases from three to eight hours daily; method of delivery does not change.
- The Instructor assigned to each course will remain throughout all phases and one DA Form 1059 will reflect all phases at the conclusion of the course.
- Phase 1 course length was pre-determined by each student's respective proponent and will either be three, six, or seven days.
- 88K40, 88L40 SLC and CMF 94 ALC are the only courses with a Phase 3 and NCOs will receive a third ATRRS reservation from HRC.
- **51C40 SLC** is the only course that remains resident fully.

Phase 2: Students will physically report to Fort Gregg-Adams, Fort Walker, or JBLE, Virginia on the date depicted on their ATRRS reservation and receive resident instruction for the remainder of their course.
